You have stated your preference to pay for the plan by one lump sum because you do not like instalment plans, and you do not need to pay by instalments. We have assessed your affordability and we can see that you can easily afford to pay this amount. If you would like to proceed, please sign the enclosed application form and return it to us with payment using the enclosed business reply envelope. I strongly recommend that you complete the enclosed Funeral Wishes form and return it with your application however from many years' experiences I know that some people like to take their time with this form, and you can send this form later if you wish.

Please note that Funeral Plans are now regulated by The Financial Conduct Authority which provides you with additional protection. The new regulation means that commission is no longer paid to us when we provide you with a funeral plan. We discussed our fee for researching, advising, and arranging this plan and you agreed that a fee of £250 was acceptable and our invoice is enclosed.
